### **ORDER**

The petitioner filed this writ petition for a direction to the 3<sup>rd</sup> Respondent herein to return the Key to the petitioner in respect of his house property situated at Door No.5A8 comprised in Survey No. 674/2B2, Plot No.12 at Old Dindigul Road, Vedasandur Taluk, Dindigul District and also for a direction to the 3<sup>rd</sup> Respondent not to interfere with a civil dispute between the petitioner and the 4<sup>th</sup> respondent herein.

2. Today, when the matter was taken up for hearing, the third respondent appeared before this Court, who submit that he is not in possession of the key with respect to the subject property. The said statement is recorded.

3. The learned counsel for the 4<sup>th</sup> respondent would submit that the key is in the custody of the 4<sup>th</sup> respondent, who is in possession and enjoyment of the subject property.
