The learned counsel appearing for the writ petitioner would submit that the writ petitioner has lodged a complaint before the respondent for missing of his original sale deed document bearing No.153 of 2006 dated 08.02.2006. He would further submit that the writ petitioner has also made paper publication on 23.07.2024 with regard to the missing of original document.

4. In pursuance of the direction of this Court in Crl.O.P.No.3307 of 2022, the Director General of Police has issued a circular

Considering the above, the second respondent is directed to conduct enquiry and issue Non-traceable Certificate to the writ petitioner, after ensuring the said document has not been deposited for any purpose following the circular issued by the Director General of Police within a period of one month from the date of receipt of a copy of this order.

6. With the above direction, the Writ Petition stands disposed of.
