I.A. No.2 of 2023 IN/AND WRIT PETITION Nos.3107, 3109, 3117, 3125 and 3127 OF 2023

COMMON ORDER:

In these batch of Writ Petitions, the petitioners have assailed the proceedings termed as final orders dated 28.12.2022 and the consequential notice issued on 27.01.2023, as having been issued without considering the documents submitted by the petitioner, thus, as being illegal and arbitrary.

- 2. Despite the vacate petition being listed, there is no representation on behalf of the writ petitioners.
- 3. Heard Sri M. Ram Mohan Reddy, learned Standing Counsel appearing on behalf of respondent No.4, learned Government Pleader for Home appearing on behalf of respondent Nos.3, 7 to 9 and with the consent of the learned Counsel appearing on behalf of vacate petitioner/respondent, the Writ Petition is taken up for hearing and disposal.
- 4. The case of the petitioners is that they are the absolute owners of house bearing shop Nos.21-109, 21-110/1, 15-122, 18-45/1 and 12-89 situated at Kosgi Town and Mandal, Narayanpet District having purchased the same through

registered sale deed dated 23.07.1970 from the original pattadar and are in possession of the same. Petitioners further contend that the respondent Nos.4 to 6 have illegally made a 'Red Line' marking on the petitioners property and thereafter issued notice to handover possession to the extent of demarcation made on the property.

- 5. Petitioners also contended that against the aforesaid marking done and the action of the respondents in directing the petitioners to handover possession, the petitioners have approached this Court by filing Writ Petitions and this Court while setting aside the notice dated 05.08.2022 directed the petitioners to submit explanation within two weeks.
- 6. Petitioners further contended that on this Court issuing the aforesaid direction, the petitioners have submitted their explanation on 08.11.2022 and that the respondent No.4 without considering the explanation submitted by the petitioners has issued proceedings termed as final orders dated 28.12.2022, without assigning any reasons for not considering the explanation submitted by the petitioners and further holding that the property purchased by the petitioners to be an encroachment with a further direction to remove the same within fifteen days from the date of receipt of the proceedings.

- 7. Petitioners further contended that the respondent No.4 thereafter issued proceedings dated 27.01.2023 termed as final notice by referring to the proceedings dated 28.12.2022 directing the petitioners to vacate the subject structure/land within 24 hours and handover the same to the Municipality, failing which the petitioners were informed that the authorities will take up demolition of the subject property.
- 8. Petitioners contended that the proceeding termed as final order does not indicate any basis for the authorities to hold that the petitioners have encroached on the portion belonging to the Municipality and that the authorities did not consider the registered document of purchase of subject property by them.
- 9. I have taken note of the submissions made and perused the record.
- 10. Though the respondent No.4 termed the proceedings dated 28.12.2022 as 'final order', no reasons whatsoever have been assigned therein for the authority to come to the conclusion indicated therein. Though the respondent No.4 at an earlier point of time had issued notice dated 05.08.2022 and the petitioners having submitted their explanation on 09.11.2022 (received on 15.11.2022), the same does not find any mention in the impugned proceeding dated 28.12.2022.

The non-consideration of the explanation by the respondent No.4 authority while passing the impugned order in the considered view of this Court has resulted in the impugned order having been passed in violation of principles of natural justice. Thus, for the said reason, the impugned order cannot be sustained.

- 11. Further, it is trite law that the reasons are the heart of the order and since the impugned proceeding, in the considered view of this Court, is bereft of any reasons and for the said reason also, the impugned order cannot be sustained. (See: Associate Builders v. Delhi Development Authority).
- 12. Further, neither the show cause notice nor the impugned order does not indicate the extent of alleged encroachment made by the petitioners so as to enable them to offer their explanation. Thus, for all the aforesaid reasons, this Court is of the view that the impugned proceeding cannot sustained.
- 13. Accordingly, the impugned proceedings are set aside and the matters are remitted back to the respondent No.4 to pass orders afresh by conducting proper enquiry into the matter by (i) considering the explanation submitted by the petitioners dated 09.11.2022; (ii) Afford the petitioners an opportunity of personal

hearing and also allow the petitioners to file additional documents, if any; and (iii) pass a reasoned order thereafter and communicate the same to the petitioners.

- 14. Having regard to the pendency of the Writ Petitions on the file of this Court, this Court is of the view that the respondents should be directed to complete the entire exercise within a period of two months from the date of receipt of a copy of this order.
- 15. Subject to the above observations and direction, all the Writ Petitions are disposed of. No costs.
- 16. Consequently, I.A. No.2 of 2023 in W.P. Nos.3107, 3109, 3117, 3125 and 3127 of 2033 stand closed.

As a sequel, miscellaneous petitions pending if any shall stand closed.
