## **ORDER:**

This Transfer Civil Miscellaneous Petition is filed by wife for transferring of H.M.O.P.No.343 of 2023 from the file of learned Principal Senior Civil Judge - cum - Additional Assistant Sessions Judge at Siddipet to learned Senior Civil Judge, Sircilla.

2. Heard learned counsel for the petitioner as well as learned counsel for the respondent. Perused the record.
3. Learned counsel for the petitioner submitted that the petitioner is residing with her old aged parents at Rajanna Sircilla District and is becoming difficult for her to travel to Additional Senior Civil Judge - cum- Additional Assistant Sessions Judge, Siddipet on every date of hearing as she is depending on her parents for eking out her livelihood which is burdensome to her.
4. H.M.O.P.No.343 of 2023 is filed by husband of the petitioner at learned Principal Senior Civil Judge - cum - Additional Assistant Sessions Judge at Siddipet seeking dissolution of marriage.

5. After hearing the learned Counsel for the petitioner, this Court is of the considered opinion that in respect of transfer of proceedings of a matrimonial dispute, the convenience of the wife is to be preferred over the convenience of husband, as held by the Hon'ble Apex Court in the case of **Rajani Kishor Paradeshi Vs. Kishore Babulal Paradeshi**<sup>1</sup> and **Sumita singh Vs. Kumar Sanjay and another**<sup>2</sup>.

6. In view of above, this Court is of the opinion that sufficient grounds are made out on facts and in law to accept the plea of the petitioner/wife for transfer of H.M.O.P.No.343 of 2023, pending on the file of learned Principal Senior Civil Judge – cum – Additional Assistant Sessions Judge at Siddipet to learned Senior Civil Judge, Sircilla.

7. In the circumstances, H.M.O.P.No.343 of 2023, pending on the file of learned Principal Senior Civil Judge – cum – Additional Assistant Sessions Judge at Siddipet is withdrawn and is transferred to learned Senior Civil Judge, Sircilla

8. In the result, the Tr.C.M.P. is allowed. No Costs.
