Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or orders more particularly one in the nature of writ of Mandamus holding the action of the Respondents No. 2 to 4 in not considering Petitioner's representation dated 01.03.2024 to delete/remove petitioner's inherited patta land to an extent of Ac.0.20 gts., in Sy.No.1043/A and Ac.0.20 gts., in Sy.No.1043/A2 situated in Ameenpur Village, Ameenpur Mandal, Sangareddy District, from the list of 'Prohibited Lands as illegal, arbitrary and in violation of principles of natural justice and to consequently direct the Respondents No.2 to 4 herein to consider Petitioner's representation dt. 01.03.2024 and issue fresh pattadar passbooks in respect of Petitioner's patta land to an extent of Ac.0.20 gts., in Sy.No.1043/A and Ac.0.20 gts., in Sy.No.1043/A2 situated in Ameenpur Village, Ameenpur Mandal, Sangareddy District in the interest of justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents No.2 to 4 herein to consider Petitioner's representation dt. 01.03.2024 and issue fresh pattadar passbooks in respect of Petitioner's patta land to an extent of Ac.0.20 gts., in Sy.No.1043/A and Ac.0.20 gts., in Sy.No.1043/A2 situated in Ameenpur Village, Ameenpur Mandal, Sangareddy District in the interest of justice pending disposal of the above writ petition.

WRIT PETITION No.8110 of 2024

ORDER:

Heard Smt. K. Annapurna Reddy, learned counsel for the petitioner and Sri S. Srinivas Reddy, learned Assistant Government Pleader for Revenue.

2. Petitioner herein is claiming that he is absolute owner and possessor of land admeasuring Ac.0-20 gts each in Sy.Nos.1043/A and 1043/A2, situated at Ameenpur Village and Mandal, Sangareddy District. In proof of the same, he has filed copy of pahani for the year 2019-2020 and also Dharani status. However, he has not filed old or latest Pattadar passbook and title deed. According to the petitioner, the aforesaid property was mentioned in prohibited list. Therefore, he had submitted a written representation dated 01.03.2024 with the 2nd respondent with a request to delete the aforesaid property from the prohibited list. Despite receiving and acknowledging the said written representation, respondent No.2 is not disposing of the same. Therefore, the present Writ Petition.

3. Whereas, Sri S.Srinivas Reddy, learned Assistant Government Pleader for Revenue, on instructions would submit that

the 2nd respondent will consider the said representation submitted by the petitioner and dispose it of strictly in accordance with law.

4. In the light of the aforesaid submission, this Writ Petition is disposed of directing the 2nd respondent to dispose of the aforesaid written representation dated 01.03.2024 submitted by the petitioner and pass appropriate orders strictly in accordance with law by putting the petitioner and all effected parties on notice and affording them an opportunity of hearing. If, 2nd respondent is not inclined to accept the request made by the petitioner, he shall assign specific reasons and pass a reasoned order, communicate copy of the said order to the petitioner and complete the said exercise within a period of eight (08) weeks from the date of receipt of a copy of this order. There shall be no order as to costs.

As a sequel, the miscellaneous petitions, if any, pending in the Writ Petition shall stand closed.

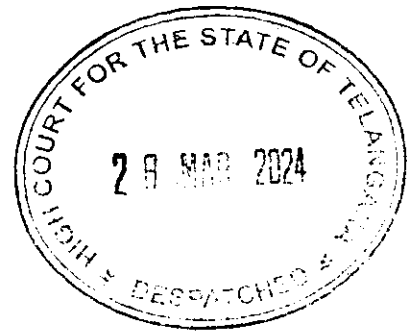
