ORDER : (ORAL)

This writ petition is filed by the petitioner seeking following relief:

“... to issue a Writ order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction of the Respondents in registering the complaint dt.23-03-2024 is illegal, arbitrary, violative of Articles 14 and 21 of the Constitution of India besides violative of Principles of Natural Justice and contrary to the judgement of the Honble Apex Court reported in **Lalitha Kumari v. Government of Uttar Pradesh, 2014 2 SCC 1** and consequently direct the Respondents to forthwith register the complaint and conduct an investigation and pass ...”

2. Learned Assistant Government Pleader for Home submitted that pursuant to the complaint of the petitioner dated 23.03.2024, a crime was registered in FIR No.241 of 2024 for the offences punishable under Sections 408, 420 and 506 read with Section 34 of the Indian Penal Code (for short, 'IPC') on the file of Shadnagar, Police Station. A copy of FIR is served on learned counsel for the petitioner.

3. In view of the above submission of the learned Assistant Government Pleader for Home, no further orders are required to be passed in this writ petition. Accordingly, the writ petition is disposed of.

As a sequel thereto, miscellaneous applications, if any, pending in the writ petition stand closed. There shall be no order as to costs.
