Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or direction more particularly one in the nature of writ of mandamus declaring the highhanded action of the respondents in trying to interfere with peaceful possession and enjoyment of the petitioner over the property admeasuring Ac.2.00 guntas under Sy.No.49/5 situated at Bahadurguda Village, Saroornagar Mandal, Ranga Reddy District as illegal, arbitrary, unjust, unconstitutional and violative of principles of natural justice and consequently direct the respondents not to interfere with peaceful possession and enjoyment of the petitioner over the property admeasuring Ac.2.00 guntas under Sy.No.49/5 situated at Bahadurguda Village, Saroornagar Mandal, Ranga Reddy District without following due procedure contemplated as per law.

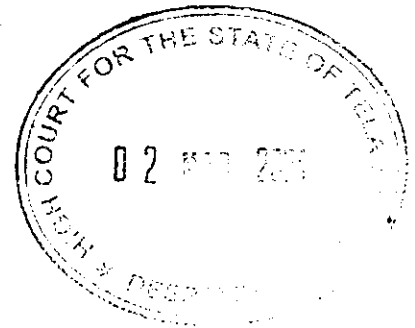
