The Court made the following: COMMON ORDER

THE HON'BLE SRI JUSTICE T. VINOD KUMAR

WRIT PETITION Nos.22234, 22278, 22289, 22301, 22314, 22356, 22374, 22427, 22428 and 22493 of 2023

COMMON ORDER:

Since the issue involved in the present Writ Petitions is one and the same, they are being disposed of by this common order.

- 2. Heard learned counsel for petitioners, learned Government Pleader for Municipal Administration and Urban Development appearing for respondent No.1 and Sri M.Dhananjay Reddy, learned Standing Counsel appearing on behalf of respondent Nos.2 and 3, and perused the record.
- 3. The case of the petitioners in brief is that the respondent authorities have issued notice, and without passing any order thereon and without following due process of law, are threatening to demolish the structures belonging to the petitioners, which action it is contended is highly illegal, arbitrary and unconstitutional and contrary to the provisions of the Greater Hyderabad Municipal Corporation Act, 1955 (for short 'the Act') part from violative of Articles 14, 21 and 300-A of the Constitution of India, with a consequential direction to respondents not to

demolish the aforesaid structures of the petitioners without following due process of law.

- 4. Counter-affidavit on behalf of respondents is filed.
- 5. By the counter-affidavit, the respondents claim that petitioners having undertaken constructions without obtaining valid permission or sanction from the respondent authorities, the authorities have caused a show cause notice to the petitioners calling upon them to submit their explanation to the same.
- 6. By the counter-affidavit, it is further stated that since the petitioners did not submit any explanation, the authorities have passed a speaking order holding the subject constructions made by the petitioners to be unauthorized and illegal constructions.
- 7. By the counter-affidavit, it is also stated that when the authorities sought to serve the speaking order on the owners/occupiers of the subject premises as they have refused to receive the same, the authorities have served the same by way of affixture, and thus, it is not open for the petitioners to allege and claim of not being served either with the show cause notice or the

speaking order preventing the authorities from taking further action thereon.

- 8. I have taken note of respective contentions urged.
- 9. Though, the respondent authorities claim of initiating action firstly by issuing show cause notice and thereafter by passing speaking order as the petitioners failed to submit any reply to the show cause notice, it is not shown to this Court of the respondent authorities taking steps for serving the speaking order stated to have been passed on the petitioners being the owners/occupiers in the manner prescribed under Section 630 of the Act. Though, respondents claim of having served the speaking order by way of affixure, it is to be noted that the resort to serving the notice/summons/orders etc by affixture is to be undertaken only after exhausting other three modes of service prescribed under Section 630 of the Act.
- 10. Inasmuch as the respondents claim of serving the speaking order by affixture without exhausting the three modes of service prescribed under Section 630 of the Act, the claim of the respondents of petitioners refusing to receive the speaking order

when sought to be served on them, resulting in authorities having served the same by way of affixture cannot be held as valid mode of service for the authorities to take further action thereon.

- 11. Accordingly, the speaking order passed by the respondent authorities in all these cases are set aside; the matters are remitted back to the respondent authorities to cause fresh notice to the petitioners affording sufficient time to submit their explanation; pass speaking order thereafter; and serve the same on petitioners in the manner prescribed under Section 630 of the Act.
- 12. Subject to above direction, the Writ Petitions are disposed of. No costs.
- 13. As a sequel, miscellaneous petitions pending if any shall stand closed.
