Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents in not registering the FIR against the unofficial respondent No. 6 to 9 though the cognizable offence

committed by them in pursuant to the petitioners' complaint dated 27-07-2024 as illegal, arbitrary, unconstitutional, violative of Principles of natural justice and contrary to the judgment of the Hon'ble Supreme Court and consequently direct the Official Respondents to register the FIR duly effecting the arrest of the accused and conduct investigation by following due procedure of law.

ORDER: (ORAL)

This writ petition is filed to declare the action of the respondents, in not registering the First Information Report against the unofficial respondent Nos.6 to 9 pursuant to the petitioner's complaint dated 27.07.2024, as being arbitrary and unconstitutional.

2. Learned counsel for the petitioner submitted that subsequent to filing of the writ petition, First Information Report No.317 of 2024 of Balapur Police Station, under Sections 329 (3) and 324 (4) read with Section 3(5) of Bharatiya Nyaya Sanhita was registered on the complaint of the petitioner dated 27.07.2024 and, thus, the cause in the writ petition does not survive for adjudication.

3. Recording the above submissions, the writ petition is disposed of as no further orders are required to be passed. No order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in the writ petition stand closed.
