Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly in the nature of Writ of Mandamus declaring the action of the respondent No.2 and 3 for not demolishing the illegal construction raised by Respondent No-4, over land in Sy No- 190 and 191 admeasuring Ac.1-20 gts situated at Mallampet Village, Dundigal-Gandimysamma Mandal, Medchal Malakjgiri District even inspite of the complaint dated 18.04.2024, and legal notice dated 29/04/2024, as illegal arbitrary, unjust and unconstitutional, being violation of Article 14, 21 and 300 - A of the Constitution of India.
