Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondent No.3 in issuing Notice under Section 114, 124 of T.S.Panchayath Raj Act, 2018 dated 22-8-2024 as is illegal, arbitrary, contrary to the T.S.Panchayath Raj Act, and not considering the explanation filed by the petitioner dated 27-8-2024 threatening to demolish the petitioner compound wall house bearing No. H.No.4-18 situated at Munigadapa village, Jagdevpur Mandal, Siddipet district is violation of Principles of natural Justice and consequently direct the respondents not to take any further coercive steps for demolition of compound wall of the petitioner house stated above.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all further proceedings pursuant to notice dated 22-8-2024 issued by the 3<sup>rd</sup> respondent by directing the Respondents not to demolish the petitioner compound wall house bearing No. H.No.4-18 situated at Munigadapa village, Jagdevpur Mandal, Siddipet district pending disposal of the Writ petition

**ORDER:**

Heard learned counsel for the petitioner, learned Assistant Government Pleader for Panchayat Raj and Rural Development for the respondent Nos.1, 2 and 4, learned Standing Counsel for the respondent No.3 and perused the entire material on record.

2. The petitioner filed the present writ petition questioning the action of the respondent No.3 in issuing Notice under Section 114 and 124 of the Telangana Panchayat Raj Act, 2018, dated 22.08.2024 and in not considering the explanation submitted by the petitioner dated 27.08.2024 and threatening to demolish the petitioner's compound wall house bearing No.H.No.4-18 situated at Munigadapa Village, Jagdevpur Mandal, Siddipet District.

3. After hearing both sides, the writ petition is disposed of directing the respondent No.3 to consider the explanation dated 27.08.2024 submitted by the petitioner, in pursuance to the notice issued by the

respondent No.3 *vide* dated 22.08.2024 and shall pass appropriate orders in accordance with law. Till then, the respondents are directed not to take any coercive steps against the petitioner. There shall be no order as to costs.

4. Miscellaneous petitions pending, if any, shall stand closed.
