ORDER:

This writ petition is filed seeking the following relief:-

"to call for the records prior to the impugned proceedings C.C.L.A's Ref No.pen-II/1188/2010, dated 29.01.2016 of the 2nd respondent and declare the same as illegal, arbitrary and against the Rules of A.P revised pension Rule 1980 and set aside the same and consequently declare the applicant is entitled to get two increments and Gratuity with all consequential benefits arise there from..."

- 2. When the matter is taken up for hearing, learned Government Pleader for Services II produced copy of G.O.Ms.No.85 Revenue (Vigilance-I) Department, dated 03.03.2022 issued by the Government of Andhra Pradesh, imposing the punishment of withholding of full pension and entire gratuity amount permanently on the petitioner herein.
- 3. Learned counsel for the petitioner submitted that writ petition may be disposed of granting liberty to the petitioner to challenge G.O.Ms.No.85, dated 03.03.2022.
- 4. In view of the above submission of the learned counsel for the petitioner, the writ petition is disposed of with liberty as prayed for. There shall be no order as to costs.

Pending miscellaneous applications, if any, shall stand closed.
