Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any writ order or direction preferably a writ in the nature of mandamus declaring the inaction of the Respondents in not paying the compensation to the petitioner for the land acquired by the respondents in respect of premises bearing No.12-7-275, sitaute at Mettuguda, secunderabad in terms of Notification No.A/1261/2007 dated 27.11.2007 issued under the provisions of the Land Acquisition Act, as illegal, arbitrary, and violative of Article 14 and 300A of the Constitution of India; and consequently direct the respondents to forthwith pay the compensation to the petitioner for the land acquired by the respondents in

respect of premises bearing No.12-7-275, situate at Mettuguda, Secunderabad in terms of Notification No.A/1261/2007 dated 27.11.2007 issued under the provisions of the Land Acquisition Act pending disposal of the above writ petition.
