# ORDER:

This petition is filed against the order dated 27.09.2022 passed in E.P.No.439 of 2015 in E.P.No.276 of 2018 in M.V.O.P.No.439 of 2015 on the file of II Additional District and Sessions Judge at Sangareddy.

- Notice sent to respondent No.1 not yet returned and notice sent to respondent No.2 returned with an endorsement refused and therefore, there is no representation on behalf of the respondents.
- Heard arguments of learned counsel for the Insurance Company.
- 4. It is submitted that initially O.P.No.184 of 2015 was filed before the trial Court for the same accident and the matter was settled before Lok Adalat for an amount of Rs.2,00,000/- and the said amount was deposited and later respondent No.1 filed O.P.No.439 of 2015 in which trial Court granted an amount of Rs.1,22,500/- with interest @ 7.5% per annum from the date of petition till the date of realization. Later they filed E.PNo.276 of 2018 and in docket order dated 27.09.20022 the trial Court ordered for issue of warrant of attachment against movable

property of petitioner/J.D.R.2 then they brought it to the notice of the Court and also filed an I.A.No.312 of 2018 for review of order of the trial Court in O.P.No.439 of 2015.

On 26.11.2021, the trial Court observed that it is not elerical or arithmetical error to be reviewed and it is for the parties to approach the Appellate Court for setting aside the judgment.

- 5. Admittedly, two O.Ps are filed for the same accident and the previous O.P amount was deposited by Insurance Company and they cannot be burdened again to deposit amount in another O.P filed for the same accident and it is the mischief committed by the claimants though they settled before the Lok Adalath they proceeded with another O.P and got that order and it is to be curtailed. Therefore, this Court finds it reasonable to set aside the award in O.P.No.439 of 2015 dated 26.11.2021 and also finds it reasonable to set aside the order dated 27.09.2022 passed in E.P.No.439 of 2015 in E.P.No.276 of 2018.
- In the result, civil revision petition is allowed by setting aside the order dated 27.09.2022 passed in E.P.No.439 of 2015 in E.P.No.276 of 2018 and also order

dated 26.11.2021 passed in M.V.O.P.No.439 of 2015 on the file of II Additional District and Sessions Judge at Sangareddy. There shall be no order as to costs.

Miscellaneous petitions pending, if any, shall stand closed.
