# THE HONOURABLE SRI JUSTICE SUJOY PAUL <u>CIVIL REVISION PETITION No.3723 of 2024</u> ORDER:

behalf of Sri V.Ramachander Goud, learned counsel for the petitioner submits that in order to substantiate the objection regarding delay in filing the E.P., the petitioner wanted certain docket orders, for which, he preferred a copy application which is evident from page No.14. The said application was registered as C.A.No.26527 of 2024 on 23.10.2024 and the same was rejected by assigning one line in the order i.e., "Return-Office note can't be Issue. Hence C.A. not complied." Learned counsel further submits that the said documents are necessary to establish there is a delay in filing the E.P. The E.P. petitioner therein played fraud with the Court. There should not have been any objection in providing docket orders, which are not confidential documents.

2. Considering the fact that the said application dated 23.10.2024 is rejected without assigning any reason, I deem it proper to set aside the said finding and revive the application dated 23.10.2024 on the file of the trial Court. The trial Court

shall rehear the petitioner on the said application and pass a reasoned order, in accordance with law and thereafter, may proceed with E.A.No.342 of 2024 in E.P.No.194 of 2024.

Accordingly, the Civil Revision Petition is disposed of 3. without expressing any opinion on merits of the case. No costs.
