**CRIMINAL REVISION CASE No.1875 OF 2009**

**ORDER:**

1. The Criminal Revision Case was filed by the petitioner-husband, against the Order of the Additional Metropolitan Sessions Judge for the trial of JHCBBC-cum-Additional Family Court-cum-XXIII Additional Chief Judge, Hyderabad, in M.C.No.302/2007, dated 17.08.2009, whereby the learned Judge granted monthly maintenance of Rs.4,000/- to the wife- 1<sup>st</sup> respondent herein.
2. None appears for the revision petitioner and the 1<sup>st</sup> respondent.
3. On 10.11.2009, this Court in Crl.RC.MP.No.2627 of 2009 granted interim suspension of the order dated 17.08.2009 passed in MC.No.302/2007, on condition of the revision petitioner paying Rs.2,000/- per month to the 1<sup>st</sup> respondent-wife on or before 10<sup>th</sup> day of every succeeding month and also shall pay half of the total arrears of the maintenance amount within a period of eight weeks from the date of the order.
4. Since there is no appearance of the parties, this Court deems it appropriate to dispose of the revision case giving liberty to the

parties to approach the Court below seeking alteration of maintenance, if so advised.

5. Accordingly, the Criminal Revision Case is disposed off.

As a sequel, miscellaneous applications, if any, pending shall stand closed.


