This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri ENUGANTI SUDHANSHU RAO, Advocate for the Petitioner and of Sri Jithender Rao Veeramalla, the Additional Public Prosecutor for the State of Telangana on behalf of the Respondent No.1 and None Appeared for the Respondent No.2.

The Court made the following: ORDER

HON'BLE SMT. JUSTICE JUVVADI SRIDEVI CRIMINAL PETITION No.14556 of 2024

ORDER:

Petitioner, who is arrayed as accused No.1 in Crime No.233 of 2024 of P.S. Central Crime Station, Hyderabad, registered for the offences under Sections 420, 406, 408, 468 and 471 r/w. 120-B of IPC, is seeking to quash the proceedings against him.

- 2. Heard Sri E.Sudhanshu Rao, learned counsel for petitioner and Mr. Jithender Rao Veeramalla, learned Additional Public Prosecutor appearing for the State and perused the record.
- 3. Though this petition is filed for quashing the proceedings in the crime, during the course of arguments, learned counsel for petitioner has sought for directions to the Police to proceed with investigation by issuing notice under Section 35(3) of Bharatiya Nagarik Suraksha Sanhita (BNSS) (Previously Section 41-A of Cr.P.C.).
- 4. In view of the above, without going into merits of the matter, this criminal petition is disposed of directing the Police

concerned to proceed with the investigation in the above crime after issuing notice under Section 35(3) of BNSS (Previously Section 41-A of Cr.P.C.) to the petitioner and he shall also follow the guidelines of Hon'ble Supreme Court in Arnesh Kumar v. State of Bihar and another¹. However, the petitioner shall submit their defense and co-operate with the Investigating Officer as and when required by furnishing information and produce all relevant documents/material required for the purpose of the investigation and the Investigating Officer shall consider the same before filing appropriate report before the learned Magistrate concerned.

Miscellaneous application pending, if any, shall stand closed.
