ORDER:

This Criminal Petition is filed by the petitioner seeking to set aside the order in Crl.M.P.No.704 of 2024 in C.C.No.1088 of 2019 passed by the I Additional Junior Civil Judge-cum-VII Additional Metropolitan Magistrate at Rachakonda at Hayathnagar.

- 2. Heard Sri J.C.Francis, learned counsel for the petitioner and Sri Jithender Rao Veeramalla, learned Additional Public Prosecutor for respondent No.2 State.
- 3. Learned counsel for the petitioner submitted that after 313 Cr.P.C. examination the matter was set for defence evidence, but the accused believed that the Court would pass over the matter for defence evidence and as a result of petitioner's silence, the Court closed the defence evidence and scheduled the case for arguments. Subsequently the petitioner filed section 311 Cr.P.C. seeking an opportunity to reopen the defence evidence for

adjudication of the matter and the same was dismissed by the trial Court. Hence seeks to set aside the said order.

- In view of the submissions made by the learned counsel for 4. the petitioner, this Court is of the considered opinion to grant one more opportunity to the petitioner and the trial Court is directed defence evidence specific date for petitioner/accused. The petitioner/accused is directed to adduce his evidence on the specific date so fixed by the trial Court, in default of which this order gets automatically vacated.
- Accordingly, the Criminal Petition is disposed of. 5.
