Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue a Writ or direction more particularly one in the nature of Writ of Mandamus by declaring the impugned letter dated 16-12-2015 issued by the Respondent No. 2, vide Lr. No. AE/OP/Shapoor/F, No./D. No. 573/15, as Null and void and consequently direct the Respondents to provide the electricity connection for petitioner property i.e., Land admeasuring Ac. 3-00 in Survey No. 220/4 situated at Shahpur Village, Shamshabad Mandal, Ranga Reddy District, without making any demand made in the Lr. No. AE/OP/Shapoor/F, No./D. No. 573/15, dated 16-12-2015, in the interest of justice

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased direct the Respondents herein to provide the electricity connection for petitioner i.e., Land admeasuring Ac. 3.00 Gts., in Survey No. 220/4, situated at Shahpur Village, Shamshabad Mandal, Ranga Reddy District, without making any demand made in the Lr. No. AE/OP/Shapoor/F, No./D. No. 573/15, dated 16-12-2015, in the interest of justice

ORDER:

Heard Sri Pawan Kumar Agarwal, learned counsel appearing on behalf of the petitioner and Sri R. Vinod Reddy, learned Standing Counsel for TSSPDCL, appearing on behalf of the respondents.

2. The petitioner approached the Court seeking prayer as under:

"...to issue Writ, order or direction more particularly one in the nature of Writ of mandamus by declaring the impugned letter dated 16-12-2015 issued by the Respondent No.2 vide Lr.No.AE/OP/Shapoor/F.No. D/No.573/15, as null and void and consequently direct the Respondents to provide the electricity connection for petitioner property i.e, land Admeasuring Acs.3.00 Gts., in Survey No.220/4, situated at Shahpur Village, Shamshabad Mandal, Ranga Reddy District without making any demand made in the Lr. No.AE/OP/Shapoor/F.No.D/No.573/15,dt 16-12-2015 in the interest of justice and pass such other and further order or orders as this Hon'ble Court deems fit and proper."

3. The main grievance of the petitioner is that inspite of petitioner's application on 06.10.2015 seeking electricity service connection for petitioner's property in land admeasuring Acs.3.00 Guntas, in Sy.No.220/4, situated at Shahpur Village, Shamshabad Mandal, Ranga Reddy District, the respondents have not taken any decision on the petitioner's application as on date.

4. It is further case of the petitioner that the petitioner even deposited an amount of Rs.88,736/- way back on 07.10.2015. However the request of the petitioner made on 06.10.2015 had not been considered as on date.

5. Sri R. Vinod Reddy, learned Standing Counsel appearing on behalf of the respondents submits that the subject premises need to be inspected by the Officers concerned and the decision to be taken in the matter shall be in pursuance to the physical inspection to be done in respect of the subject premises.

6. *Taking into consideration the said submission made by Sri R. Vinod Reddy, learned Standing Counsel appearing on behalf of the respondents, the writ petition*

is disposed of, directing the respondents to conduct inspection of the subject premises of the petitioner pertaining to land admeasuring Acs.3.00 Guntas., in Sy.No.220/4, situated at Shahpur Village, Shamshabad Mandal, Ranga Reddy District within a period of one week from the date of receipt of a copy of the order in the presence of the petitioner herein and the Officers concerned after giving prior notice to the petitioner and take a decision in the matter within a period of two (2) weeks thereafter, in accordance to law and communicate the said decision to the petitioner. However, there shall be no order as to costs.

As a sequel, the miscellaneous petitions, if any, pending in the Writ Petition shall also stand closed.
