CRIMINAL REVISION CASE No.970 OF 2014

O R D E R:

The present Criminal Revision Case is filed aggrieved by the order dated 25.03.2014 C.C.SR.No.4559 of 2013 on the file of learned VIII Additional Chief Metropolitan Magistrate, Hyderabad in (for short, "the trial Court"), wherein and whereby the learned Judge of the trial Court had dismissed the private complainant stating that the dispute between the parties is purely civil in nature and that no *prima facie* case is made out against the accused for the offences under Sections 120(b), 304, 323, 363, 406, 420, 423, 427, 447, 464 and 506 of IPC.

2. No representation on behalf of the petitioners. Heard Mr. Ramakotaiah, learned Assistant Public Prosecutor appearing for respondent State.
3. This Court is inclined to proceed with the matter on merits of the case as per the decision of the Hon'ble Apex Court in "***Bani Singh and others Vs. State of Uttar Pradesh***"*, wherein it was categorically held that the High Court cannot dismiss any appeal for non-prosecution *simpliciter* without examining the merits.

4. This Court vide order dated 27.04.2022 in CrI.R.C (SR) No.3198 of 2022 held that as against an interlocutory order, a Revision under Section 397 of Criminal Procedure Code is not maintainable.

5. In view of the facts and circumstances of the case, this Court is not inclined to entertain the Criminal Revision Case at this stage, as the proceedings hereunder are covered by the order dated 27.04.2022 in CrI.R.C (SR) No.3198 of 2022 passed by this Court.

6. Accordingly, the Criminal Revision Case is dismissed. Needless to mention, the petitioner is at liberty to work out the remedies available under law.

Miscellaneous Petitions, pending if any, shall stand closed.
