## N.S.Shekhawat J. (Oral)

The petitioner has filed the present petition under Section 439 Cr.PC with a prayer to grant regular bail to him in case FIR No. 175 dated 19.07.2023, registered under Sections 379-B of IPC (Sections 379,411,489 of IPC and Section 28/54/59 of Arms Act added later on), Police Station Maqboolpura, Amritsar, District Amritsar.

2. The FIR in the present case was registered on the basis of the statement made by Ajay Kumar son of Mangaljit Sharma and the same has been reproduced below:-

"Statement of Ajay Kumar, aged 43 years, son of Mangaljit Sharma, resident of Gali Post Office Wali, Patti Gatha Wali Village Vallah, District Amritsar, Mobile No. 9803914110. Stated that I am resident of the above given address and I am doing a private job. Today I along my mother Asha Rani were standing at my grocery shop outside the Chowk of Channa Sarpanch and then suddenly from the post office side of the village a hair cut boy came there riding an unnumbered motorcycle make Passion and

then he snatched away the gold earring from the left ear of my

mother and tried to run away from the spot. But as he was about to

run away, his motorcycle got out of balance and he fell down.

Thereafter, with the help of nearby people he was apprehended.

Due to falling down from his motorcycle he has received multiple

injuries. On hearing the turmoil many other persons from the

vicinity got together at the spot and we have apprehended him and

he is also having a toy pistol in his possession. So I have come to

the police station for giving information with the request to take

the above apprehended person in the police custody and for taking

legal action against him. I have heard my statement which is

correct. Sd/- Ajay Kumar, aged 43 years, son of Mangaljit

Sharma, resident of Gali Post Office Wali, Patti Gatha Wali

Village Vallah, District Amritsar.

3. Learned counsel for the petitioner contends that the petitioner was

not involved in the alleged incident of snatching and a false case has been

planted on him. He further submits that the petitioner was arrested in the

present case on 19.07.2023 and no recovery was effected from him. He further

contends that the final report under Section 173 of Cr. P.C has already been

presented before the competent Court and the prosection has been able to

examine only 06 witnesses out of total 10 witnesses so far. Learned counsel

further submits that the petitioner is a young person and not involved in any

criminal activity.

4. On the other hand, learned State counsel has vehemently opposed

the prayer made by learned counsel for the petitioner on the ground that the

serious allegations have been levelled against the present petitioner and the

petitioner does not deserve the concession of bail.

5. I have heard the learned counsel for the parties and perused the

record.

**6.** The petitioner was arrested in the present case on 19.07.2023

and 06 witnesses out of total ten witnesses have already been examined by the

prosecution. Thus, the petitioner may not be in a position to influence the

witnesses of the prosecution, at this stage. Since the petitioner has already

incarceration for more than six months and no further purpose would be served

by keeping the petitioner behind the bars.

7. Without commenting on the merits of the case, the present

petitionis allowed and the petitioner is ordered to be released on bail subject to

her furnishing bail bonds/surety bonds to the satisfaction of the trial Court/Duty

Magistrate/Chief Judicial Magistrate, concerned.
