<u>Per Ramesh Sinha, Chief Justice</u> 30/06/2025

- Hear Mr. Kuldeep Singh Sisodia, Petitioner in Person. Also heard Mr. Nitansh Jaiswal, learned Panel Lawyer for the respondents/ State.
- 2. The petitioner has filed this petition praying for following relief:-
 - "1. Quash FIR No. 0239/2019 dated 06.07.2019, registered at P.S. DDU Nagar Thana, Raipur, u/s 498A read with 34 IPC and Sections 3/4 of the Dowry Prohibition Act, 1961, along with the subsequent chargesheet and proceedings in Case No. 7976/2019 pending before the Judicial Magistrate First Class, Raipur, Chhattisgarh.

- 2. Grant any other relief deemed just and equitable in the circumstances of the case, in the interest of justice."
- 3. The petitioner in person submits that he has already filed an application for discharge under Section 227 of the Cr.P.C. before the trial Court and the same is pending. Therefore, he seeks permission of this Court to withdraw the present petition, with liberty to file a fresh petition, if any cause of action arises in future.
- 4. Accordingly, this petition is **dismissed as withdrawn**, with liberty as stated above.
