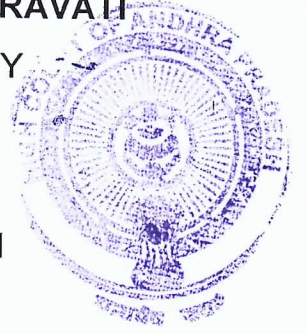

The Court made the following:

The petitioners are arraigned as accused Nos.2 and 3 in Crime No.230 of 2025 on the file of Prohibition and Excise Police Station, Rajamahendravaram South, East Godavari District, for the alleged offence under Section 7 B r/w 8 B of the Andhra Pradesh Prohibition (Amendment) Act, 2020.

2. Heard learned counsel for the petitioners and the learned Assistant Public Prosecutor.

3. Considering the submissions, this Court is inclined to grant bail to the petitioners in the event of their arrest, subject to the following condition:-

- (i) The petitioners shall be enlarged on bail in the event of their arrest upon furnishing a personal bond for Rs.10,000/- (Rupees Ten Thousand only) each, along with two sureties for a like sum each, to the satisfaction of the Station House Officer, Prohibition and Excise Police Station, Rajamahendravaram South, East Godavari District.

4. With the above condition, the criminal petition is **allowed**.

Miscellaneous petitions, if any pending, in the Criminal Petition, shall stand closed.
