**WRIT PETITION NO.15127 of 2025**

**ORDER:**

1. The present Writ Petition is filed questioning the action of the Respondent authorities in not releasing the amount of Rs.17,98,385/- payable to the Petitioner even after finalizing the bills in relation to work vide Work vide Agreement No.280/2022, dated 20.01.2023, as illegal and arbitrary.
  
2. At the time of hearing, learned Standing Counsel for the Respondent-Corporation passed on the instructions signed by the Executive Engineer, GVMC, Visakhapatnam, wherein the work done by the Petitioner was not disputed and further it was stated that bill was raised for gross amount of Rs.17,98,385/- and net amount of Rs.16,52,981/- and the same was uploaded in CFMS portal with the token number 2023-1899414 and is awaiting fund clearance.
  
3. As there is no dispute regarding the execution of work and the amounts due to the Petitioner, the Writ Petition is disposed of, at the stage of admission, with the consent of both sides counsel, with the following direction:
  - (i) The Respondent authorities are directed to pay the amount due to the Petitioner within a period of four (4) months from today.

4. No order as to costs.
5. As a sequel, pending applications, if any, shall stand closed.
