The Court Made the Following Order:-

This Criminal Petition, under Sections 480 and 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023, has been filed by the petitioner/A2, seeking regular bail, in Crime No.194 of 2020 of Vizianagaram Rural Police Station, registered for the offences punishable under Sections 20(b)(ii)(C) read with 8(c) of the Narcotic Drugs and Psychotropic Substances Act, 1985.

2. Case of the prosecution, in brief, is that, on 17.09.2020, on receipt of credible information, the Sub-Inspector of Police, along with his staff and mediators, rushed to BT Road at Y Road Junction, Vizianagaram, and noticed an Indica Car bearing No.AP 30 F 0842 and found 69.58 Kgs of Ganja in the said car. The

contraband, along with other material, was seized under cover of a mediators report.

3. Heard. Perused the record.

4. The petitioner has been in judicial custody since 19.01.2025. The quantity of contraband allegedly involved in the present crime is 69.58 Kgs of ganja. Learned Assistant Public Prosecutor submitted that major portion of investigation has been completed and there are no antecedents against the petitioner herein.

5. In view of the aforesaid facts and circumstances of the case, this Court is inclined to grant bail to the petitioner/A2 on the following conditions.

i) The petitioner/A2 shall be released on bail on his executing personal bond for Rs.10,000/- (Rupees Ten Thousand only) with two sureties of the like sum each to the satisfaction of the learned Special Judge for Trial of Offences under the NDPS Act-cum-I Additional District & Sessions Judge, Vizianagaram.

ii) On release, the petitioner shall appear before the Station House Officer concerned, once in a week i.e., on every Sunday between 10.00 am and 01.00 pm, till filing of the charge sheet.

iii) petitioner/A2 shall not go beyond the jurisdiction of Vizianagaram district, Andhra Pradesh State, without leave of the

trial Court and he shall make available his location through mobile phones by pairing it with the mobile phone of the Investigating Officer round the clock.

6. Accordingly, the Criminal Petition is **allowed**.
