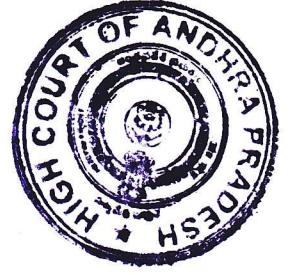

The learned counsel appearing for the petitioners submits that the petitioners have been falsely implicated in Crime No.208 of 2025 on the file of Tadepalli Police Station, Guntur District, for the alleged offence under Section 85 of the BNS and Sections 3 and 4 of the Dowry Prohibition Act.

2. The learned counsel for the petitioners further submits that the present complaint is a counterblast, filed by the husband of the 2<sup>nd</sup> respondent.

3. Be that as it may, considering the allegations against the petitioners would be punishable below seven (07) years, the police are directed to complete the investigation by following the procedure as contemplated under Section 35(3) of the Bharatiya Nagarik Suraksha Sanhita, 2023.

4. Accordingly, the Criminal Petition is disposed off.

As a sequel, pending miscellaneous petitions, if any, shall stand closed.

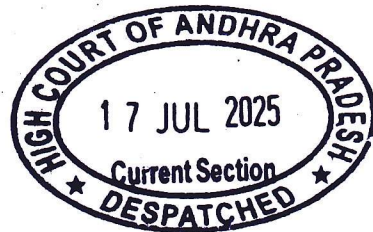
