THIS WP IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA, PRAYING TO DIRECT THE R-2 TO CONSIDER THE REPRESENTATION VIDE ANNEX-A AND FURTHER TO IMPLEMENT THE ORDER AS DIRECTED IN W.P.NO. 23572/2024 (KLR-RES) VIDE ANNEX-H, ETC.

ORAL ORDER

1. The prayer in this petition is to direct respondent No.2 to consider the representation of the petitioners dated 10.10.2024 at Annexure-A and also to implement the order passed by this Court in WP.No.23572/2024. This Court in the said writ petition had quashed the classification of land bearing Sy.No.153 as "B' kharab and had directed the authorities to restore the classification as "A' kharab.



2. Learned AGA places on record the order dated 28.04.2025 by which the land is now restored as "A" kharab land.
3. In this view of the matter, the primary prayer of the petitioners in this petition stands satisfied.
4. The petitioners are also seeking for a further direction to consider the representation dated 30.12.2024 by issuing a corrigendum to the conversion order dated 23.02.2015 by accepting conversion fine in respect of 31 guntas of reclassified "A" kharab land in Sy.No.153/1 of Uttari Village, Uttarahalli Hobli, Bangalore South Taluk.
5. Since the land is now reclassified as "A" kharab land, the 2nd respondent is directed to consider the request of the petitioner dated 30.12.2024 by issuing a corrigendum to the conversion order dated 23.02.2015 and by accepting conversion



fine in respect of aforesaid land within a period of one month from the date of receipt of a copy of this order.

6. The writ petition is accordingly disposed of.
