ORAL ORDER

In this petition, petitioner seeks for the following reliefs:

"Wherefore, it is most humbly prayed that this Hon'ble Court may be pleased to quash the FIR registered before CEN Crime Police Station, Chikkaballapura in Crime No.125/2024 and entire proceedings against the petitioner pending on the file of Hon'ble 2nd Additional Senior Civil Judge and JMFC Court Chikkaballapura, for the offence punishable under Sections 66(D) of the Information Technology Act, 2008 and under Section 316(2), 318(4) of BNS, 2023, in the interest of justice and equity."

2. Heard learned counsel for the petitioner and learned

HCGP for respondent No.1 and perused the material on record.



3. Learned counsel for the petitioner submits that petitioner has filed receipts executed by respondent No.2 for having paid a sum of Rs.2,46,500/- to respondent No.2 – Trived, who is present through video conferencing and acknowledges the receipt of the same towards full and final settlement of the claim against the petitioner.

4. The aforesaid submission is placed on record.

5. In the result, I proceed to pass the following:

- i) The petition is hereby allowed.
- ii) The impugned proceedings in Crime No.125/2024 registered by the respondent – Police on the file of the II Additional Senior Civil Judge and JMFC Court, Chikkaballapura insofar as the petitioner is concerned are quashed.
