ORAL ORDER

The petitioner in the instant petition has challenged the action initiated by the respondent - Financial Institution under Section 14 of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (for short 'SARFAESI Act').

2. The impugned order has been passed by the Court of XXXVII Addl. Chief Judicial Magistrate Court, Bangalore in pursuance of the order of secured creditors passed under Section 13(4) of the SARFAESI Act.



3. The petitioner is having alternative efficacious remedy under Section 17 of the said Act to challenge the order passed under Section 13(4) of the SARFAESI Act. The impugned order passed by the Court of XXXVII Addl. Chief Judicial Magistrate Court, Bangalore under Section 14 of the SARFAESI Act is only a ministerial order and there is no error in the same.

4. For the aforementioned reason, the writ petition is hereby dismissed.
