### ORAL ORDER

1. The petitioners are before this Court seeking following reliefs.

*"1. To Quash the FIR and further proceeding in F.I.R in Crime No. 46/2025 of J. C. Nagar Police Station, Bengaluru City, for offence under Sections 115(2), 118(1), 126(2), 3(5), 351(2), 352 of THE BHARATIYA NYAYA SANHITA(BNS), 2023, which is now pending on the file of Hon'ble 8th Addl. Chief Metropolitan Magistrates Court, Bengaluru as an abuse of process of law.*

*2. To grant such other relief or reliefs as this Hon'ble Court deems fit to grant in the facts and circumstance of the case, in the ends of Justice."*

2. Petitioner No.1 and respondent No.2 are husband and wife. Petitioner No.2 and 3 are relatives of the petitioner No.1. Certain disputes having arisen on account of the matrimonial relationship, two separate complaints have been filed. One of them being subject matter of Crl.P.No.7218/2025, the same has been disposed of today. The other complaint in Cr.No.46/2025, which is the subject matter of the above proceedings. In view of the settlement, which has been arrived at in Crl.P.No.7218/2025, the same would also enure to the benefit of the parties in the present matter. As such, I proceed to pass the following:



**ORDER**

(i) Criminal petition is ***allowed***.

(ii) FIR in Cr.No.46/2025 registered by J.C.Nagar Police Station, Bengaluru City for the offences punishable under Sections 115(2), 118(1), 126(2), 3(5), 351(2), 352 of Bharatiya Nyaya Sanhita, 2023, pending on the file of 8<sup>th</sup> Additional Chief Metropolitan Magistrate Court, Bengaluru, is hereby quashed.
