kindly be issued, directing the respondents to grant the employment to the petitioner in project (M/s Himachal Sorang Hydro Power Pvt. Ltd.) in view of the memorandum dated 23 sep. 2004 and notification dated 11 June 2007.

- II. That respondent may very kindly be directed to provide Employment permanently/through project authority in the project instead of contractor, as per the memorandum dated 23 sep. 2004 and notification dated 11 June 2007. In the interest of law and justice.
- III. That the Respondent may kindly be directed to give preference for employment in project to adversely affected family member, as a result of the acquisition of land for the project."
- 2. Learned counsel for the petitioner submits that for redressal of the grievances raised in this writ petition, petitioner has preferred a representation dated 04.10.2024 (Annexure P-4) to the Deputy Commissioner Kinnaur at Rekong Peo-respondent No.3 for claiming the above reliefs. Learned counsel further submits that the petitioner would be content in case respondent No.3/competent authority is directed to decide the aforesaid representation within a fixed time schedule. Learned Additional Advocate General is not averse to this prayer.
- **4.** Having regard to the afore-submissions, but without examining the merits of the matter, this writ petition

is disposed of with a direction to the respondents/ competent

authority to consider and decide the aforesaid representation

of the petitioner dated 04.10.2024 (Annexure P-4) in

accordance with law within a period of six weeks from today.

The decision so arrived at shall also be communicated to the

petitioner.

terms, so also the pending miscellaneous application(s), if

any.
