O R D E R

This Bail application is filed under Section 482 of Bharatiya Nagarik Suraksha Sanhita.

2. The petitioners apprehend arrest in a case registered by the Gautam Budha Nagar Cyber Crime Police Station, Uttar Pradesh.

3. After hearing both sides, I am of the considered opinion that this Court cannot entertain such a bail application when the case is registered in Uttar Pradesh. At this stage, the counsel appearing for the petitioners submitted that the petitioners are ready to file appropriate application before the jurisdictional court. In the meanwhile, there is apprehension of arrest.

4. Considering the facts and circumstances of the case, I think there can be a direction to the police authorities not to arrest the petitioners within the jurisdictional limit of the State of

Kerala for a period of three weeks so that the petitioners can approach the jurisdictional court with appropriate application.

Therefore, this bail application is disposed of directing the police authorities not to arrest the petitioners within the jurisdictional limit of the State of Kerala for a period of three weeks. I make it clear that this order is passed by this Court without considering the merit of the case and this order is passed only to facilitate the petitioners to approach the jurisdictional court.
