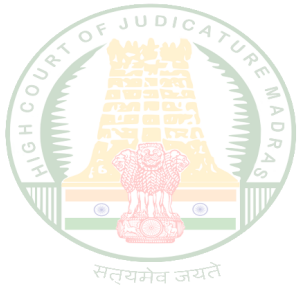

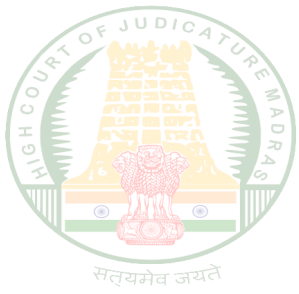
ORDER

3.The petitioner has given a representation to the respondents on 17.04.2025 in respect of the loan secured by the petitioner's father and for

issuance of a discharge certificate. According to the petitioner, the petitioner has discharged the loan as early as on 19.12.2023.


4.The learned Special Government Pleader for the respondents, on instructions, submits that a sum of Rs.85,500/- is still due as of 31.07.2025.

5.Considering the rival position taken, there shall be a direction to the respondents to consider the petitioner's representation, dated 17.04.2025, as expeditiously as possible, preferably, within a period of three months from the date of receipt of a copy of this order. The petitioner may examine as to whether the amount of Rs.85,500/- is still to be paid. In case, it is so, the petitioner shall pay the same for obtaining no due certificate from the respondents.

6.With the aforesaid directions, the Writ Petition stands disposed of. No costs.

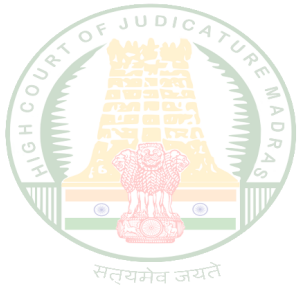
