ORDER

The petitioners seek for quashing of the FIR in Crime No.174 of 2025 on the file of the first respondent for the alleged offences under Section 296(b), 115(2) and 351(2) of BNS, 2023 and Section 82(1) of Juvenile Justice (Care and Protection of Children) Act, 2016.

- 2. It is the case of the prosecution that the first petitioner is a Teacher and the second petitioner is a Head Master of the School, in which, the defacto complainant's son is studying; and that the petitioners scolded the defacto complainant's son in filthy language and had beaten him with stick and thus committed the aforesaid offences.
- 3. The parties have now arrived at a compromise and decided to give a quietus to the entire dispute. The parties have filed a joint compromise memo dated 26th September, 2025 and the scanned copy of the compromise memo reads as follows:


