THE HON'BLE SRI JUSTICE C.V.BHASKAR REDDY CONTEMPT CASE No.708 of 2025

ORDER:

This Contempt Case is filed alleging non-compliance of the order dated 04.11.2024 passed by this Court in W.P.No.30504 of 2024.

- 2. This Court, by an order, dated 04.11.2024 while disposing of the said writ petition directing the respondent authorities to examine the petitioner's online application *vide* No.RC2400007439 dated 12.09.2024 and if the said application fulfils all the conditions laid down under Section 7 of the Telangana State Rights in Land and Pattadar Passbooks Act, 2020 (for short, 'the ROR Act, 2020'), the respondent authorities are directed to examine the same and pass appropriate orders in accordance with the provisions of the ROR Act, 2020 within a period of three months from the date of receipt of a copy of the said order. Alleging non-compliance of the said order, this contempt case has been filed.
- 3. When the matter is taken up for hearing, learned Assistant Government Pleader appearing for the respondents has placed written instructions issued by the 5th respondent-Tahsildar, Panugal Mandal in Letter No.B/241/2025 dated 26.03.2025 wherein it is stated that on receipt of the order dated 04.11.2024 passed by this Court in W.P.No.30504 of 2024 and on perusal of the material papers and revenue records, the 5th respondent-Tahsildar has considered and accepted the online application of the petitioner and passed orders *vide* reference No.B/1325/2024 dated 05.12.2024 and recommended to the Additional Collector (Revenue),

Wanaparthy District. The Additional Collector (Revenue), Wanaparthy District *vide* Proceedings No.D3/321/RC/2024 dated .03.2025 has approved the proposals and implemented the subject land in the name of the petitioner and she has been issued new e-pattadar passbook bearing No.T04080180164 with Khatha No.382.

- 4. Since it is stated that the respondents have complied with the order dated 04.11.2024 passed by this Court in W.P.No.30504 of 2024 and implemented the name of the petitioner in the revenue records, this Court is of the view that there is no willful or deliberate intention on the part of the respondents subjecting them for the rigmarole of the provisions of the Contempt of Courts Act, 1971.
- 5. Accordingly, the Contempt Case is closed. There shall be no order as to costs.

Miscellaneous petitions, if any, pending shall stand closed.
