The Court made the following: ORDER

THE HON'BLE SRI JUSTICE C.V.BHASKAR REDDY CONTEMPT CASE No.744 of 2025

ORDER:

This Contempt Case is filed alleging non-compliance of the order dated 24.10.2024 passed by this Court in W.P.No.29637 of 2024.

- 2. This Court, by an order, dated 24.10.2024 while disposing of the said writ petition directed the petitioners to submit an online application seeking deletion and de-notifying the lands from the list of prohibited properties in accordance with Sub-Section (4) of Section 22-A of the Registration Act, 1908 enclosing the certified copies of the judgments of this Court and the Hon'ble Apex Court and on filing such application by the petitioners, the respondents were directed to examine the same strictly in accordance with law and pass appropriate orders within a period of eight weeks from the date of receipt of copy of the said order and communicate the decision thereon to the petitioners. Alleging non-compliance of the said order, this contempt case has been filed.
- 3. Learned counsel for the petitioners submitted that there is no module prescribed for making an online application in Dharani Portal for deletion of the properties from the list of prohibited properties.
- 4. Whereas, learned Assistant Government Pleader appearing for the respondents submitted that there is a procedure prescribed for deletion of the properties from the list of prohibited properties in TM15 module in Dharani Portal and the petitioners instead of making an online application

for deletion of the subject properties from the list of prohibited properties in Dharani Portal have filed this contempt case.

- 5. In view of the submissions of the learned Assistant Government Pleader for Revenue for the respondents that petitioners have not made an online application for deletion of the subject properties from the list of prohibited properties in Dharani Portal in TM15 module, this Court is of the view that there is no willful or deliberate intention on the part of the respondents subjecting them for the rigmarole of the provisions of the Contempt of Courts Act, 1971.
- 6. Be that as it may, since the petitioners have not made an application in Dharani Portal, they are permitted to make an online application in Dharani Portal in TM15 module for deletion of the subject properties from the list of prohibited properties within a period of two (02) weeks from today.
- 7. With the above observations, this Contempt Case is closed.

 There shall be no order as to costs.

Miscellaneous petitions, if any, pending shall stand closed.
