WRIT PETITION No.13777 OF 2025

ORDER:

This writ petition is filed by the petitioner seeking to declare the action of respondent Nos.2 to 4, in not allotting house number to her house in Plot No.24 situated in Survey No.636 of Muthyalamma Colony, Nalgonda Town and District, as being arbitrary and unconstitutional.

2. Heard learned counsel for the petitioner and Mr. Putta Krishna Reddy, learned Standing Counsel for Municipalities, appearing for respondent Nos.2 to 4.

3. The petitioner claims to be in possession of the subject property by virtue of house site patta granted in her favour *vide* proceedings dated 25.02.1999. A house was constructed by the petitioner in the year 2010 and since then, she has been residing therein. The petitioner was given electricity connection *vide* S.C.No.4011361561 to her house. She made a representation dated 19.12.2024 to the respondent authorities for allotting house number to her house, but so far orders have not been passed thereon. As there is delay on the part of respondent Nos.2 to 4 in considering the representation of the petitioner, the instant writ petition is filed.

4. Learned Standing Counsel for respondent Nos.2 to 4 submitted that appropriate action will be taken on the representation of the petitioner.

5. In view of the above, the writ petition is disposed of directing respondent Nos.2 to 4 to consider the representation of the petitioner dated 19.12.2024, for allotting house number in respect of her house in Plot No.24 situated in Survey No.636 of Muthyalamma Colony, Nalgonda Town and District, by giving an opportunity of hearing to the petitioner, and pass orders, in accordance with law, within a period of four (04) weeks from the date of receipt of a copy of this order. No order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in this writ petition stand closed.

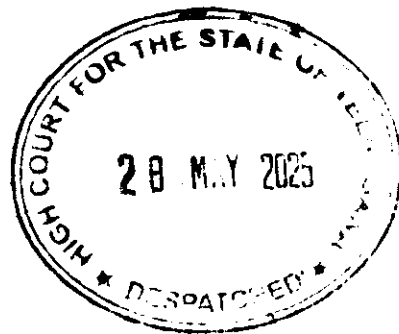
