to the petitioner with interest alias 2.4 percent per annum from date of retirement to till the date of actual payment is made.

### **ORDER:**

With the consent of both the parties, this Writ Petition is taken up for disposal, at the admission stage.

- **2.** Heard Mr. P.Ugender Reddy, learned counsel for the petitioner, learned Government Pleader for Finance appearing for respondent Nos.1 to 4 and learned Government Pleader for Education appearing for respondent No.5.
- **3.** Learned counsel for the petitioner submits that the petitioner retired from service on 31.07.2024 and till now, his retirement benefits were not released by the respondents.
- 4. Learned Government Pleader submits that the bills pertaining to the retirement benefits of the petitioner are already processed. However, due to dearth of funds, the amounts could not be released to the petitioner on time. Learned Government Pleader further submits that as per seriatim of the token numbers, amounts will be released to the beneficiaries.
- **5.** Having regard to the above submissions, this Writ petition is disposed of directing the respondents to release Gratuity (CS) amount of Rs.12,05,609/- with Token No.2522444652 dated

16.08.2024, Gratuity (TS) with amount of Rs.3,94,391/- with Token No.2522444648 dated 16.08.2024, Commutation (CS) amount of Rs.16,46,639/- with Token No.2522444647 dated 16.08.2024, Commutation (TS) amount of Rs.5,38,666/with Token No.2522444644 dated 16.08.2024 and Earned Leave and Half Pay Leave amount of Rs.12,52,390/- with Token No.2522462998 dated 20.08.2024, pertaining to the petitioner, as expeditiously as possible, preferably within a period of ten (10) weeks from the date of receipt of a copy of this order. There shall be no order as to costs.

Miscellaneous petitions pending, if any, shall stand closed.


