In view of the submission made by learned counsel appearing on either side and without expressing any opinion on the merits of the case, this writ petition is disposed of directing respondent No.3 to consider and dispose of the said representation in accordance with law within a period of one (01) week from today and communicate the same to the petitioner. No costs.
