Petition under Section 528 of BNSS praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased the Petitioners herein prays that this Court may be pleased to extend the interim order dated 10.10.2023 in CRLP.No.7169 of 2023 until further orders, during pendency of this Criminal Petition in the interest of the Justice.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri P Chandrakanth, Advocate for the Petitioner and the Sri E.Ganesh, Assistant Public Prosecutor on behalf of the Respondent No.1, and of Sri B.Mallesh Yadav, Advocate for the Respondent No.2.

The Court made the following: ORDER

CRIMINAL PETITION No.7169 OF 2023

ORDER:

This Criminal Petition is filed by the petitioners/accused Nos.1 to 3 seeking to quash the proceedings against them in C.C.No.1267 of 2022 pending on the file of the learned I Additional Judicial Magistrate of First Class, Jagtial (for short, 'the trial Court'), registered for the offences punishable under Sections 498-A, 506 r/w 34 of Indian Penal Code.

- 2. Heard learned counsel representing petitioners and Mr.E.Ganesh, learned Assistant Public Prosecutor appearing for respondent No.1-State. Perused the record.
- 3. It is the contention of the learned counsel for the petitioners that bald and omnibus allegations are made against the petitioners.

- 4. On the other hand, learned Assistant Public Prosecutor vehemently opposed to quash the proceedings against the petitioners as police have investigated the case and filed charge sheet against the accused. He further contended that it is not a fit case to quash the proceedings against the petitioners at this juncture and the matter is to be decided after conducting full-fledged trial by the trial Court.
- Having regard to the contentions advanced on either 5. side and on the facts and circumstances of the case, the appearance/attendance of the petitioners/accused Nos.1 to 3 before the learned I Additional Judicial Magistrate of First Class, Jagtial, is dispensed with, unless their presence is required by the trial Court for a specific purpose, or at the time of recording their examination under Section 313 Cr.P.C., and on the pronouncement of Judgment. However, the petitioners/accused Nos.1 to 3 are at liberty to file discharge petition and on such petition being filed, the

trial Court shall dispose of the same on merits uninfluenced by any of the observations made by this Order.

6. Accordingly, this Criminal Petition is disposed of.
Miscellaneous applications pending, if any, shall stand closed.
