#### CONTEMPT CASE No.1509 of 2024

#### ORDER:

This Contempt Case is filed alleging non-compliance of the order, dated 26.04.2024 passed by this Court in Writ Petition No.10141 of 2023.

- 2. This Court while disposing of Writ Petition Nos.21968 & 10141 of 2023 and 8263 of 2020 and Contempt Case No.1194 of 2023 *vide* common order dated 26.04.2024, ordered as follows:
  - "13. Resultantly, W.P.Nos.21968 & 10141 of 2023 and 8263 of 2020 are disposed of by relegating the parties to submit appropriate application before the Assistant Director of Survey and Land Records BhadradriKothagudem District, with a request to conduct survey of lands in Survey No.34/2 and 36/A situated in Guttamallaram Village, Manuguru Mandal BhadradriKothagudem District, duly enclosing a copy of this order and also the documents in support of their respective claims. On receipt of such application, the Assistant Director, Survey and Land Records, shall consider the said application and conduct survey and fix the boundaries of the lands forming part of Survey Nos.34/2 and 36/A situated in Guttamallaram Village, Manuguru Mandal, Bhadradri-Kothagudem District, duly verifying the documents and following the procedure prescribed under the provisions of the Telangana Survey and Boundaries Act and the circular instructions issued from time to time by the Commissioner of Survey, Settlement and Land Records and after affording opportunity to both the parties, within a period of eight (8) weeks from the date of receipt of application. It is further directed that till the said survey is completed, the petitioner in W.P.No.21968 of 2023 shall not undertake any construction in the subject property and the Secretary, Guttamallaram Gram Panchayat, shall not remove any existing structures over the subject property. It is made clear that after conducting survey and fixation of boundaries, if it is found that there are illegal constructions forming part of Survey No.36/A of Guttamallaram Village, the petitioner in W.P.No.10141 of 2023 and 8263 of 2020 may make appropriate application for removal of alleged illegal constructions, in accordance with law.
  - 14. Consequently, in view of the aforesaid orders passed in the writ petitions, C.C.No.1194 of 2023 shall stand closed. "

- 3. Alleging that inspite of the aforesaid directions issued by this Court, the respondent No.4 is proceeding with illegal construction, the present contempt case is filed.
- 4. The respondent No.4 has filed a counter affidavit, *inter alia* stating that he has not violated the orders of this Court and has not raised any structures. It is further stated that the pillar rods were already in existence earlier, and even those have been removed. At present, the land is vacant. In support of his submissions, respondent No.4 has filed photographs dated 06.03.2025 along with the counter affidavit.
- 5. Recording the above submission, this Contempt Case is closed.

Miscellaneous petitions, if any, shall stand closed.
