Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents police particularly 5th respondent police in not registering the FIR basing on the complaint of the petitioners dated 17.09.2019 acknowledged the same on 17.09.2019 is illegal, arbitrary and against the principles of natural justice and also violation of apex court rulings held in Lalitha Kumari Vs. Govt. of UP and ors and as well as Cr.P.C

and consequently direct the respondents police to entertain the complaint and register the FIR against the culprits.

IA NO: 1 OF 2019

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents police to register the FIR basing on the complaint of the petitioners dated 17.09.2019 to take action against the culprits, pending disposal of the main writ petition.

THE HON'BLE SRI JUSTICE T. VINOD KUMAR W.P.No. 21445 of 2019

ORDER:

None appears for the petitioners. Heard learned Government Pleader for Home appearing for respondent Nos.1 to 5 and Sri E.Ajay Reddy, learned counsel appearing for respondent No.6, and perused the record.

- 2. The grievance of the petitioners as set out in the affidavit filed in support of the Writ Petition is that the respondents-authorities are not taking action against the unofficial respondent herein by registering FIR on their complaint dt.17.09.2019, acknowledged on 17.09.2019, which action of the respondents it is contended as highly illegal and arbitrary.
- 3. When the matter is taken up for hearing, learned Government Pleader appearing for official respondents submits that the respondents-authorities on receiving the complaint made by the petitioners, have made a GD entry and after causing preliminary enquiry, closed the said complaint on 25.09.2019 by noting the same as "civil in nature"; and that the petitioners were also informed of the action taken by sending communication through registered post.
- 4. Having regard to the submission made as above and since, it is now stated before this Court that a communication through registered



post has been sent to the petitioners informing them of the action taken on the aforementioned complaint lodged by closing the same as "civil in nature", this Court is of the view that the grievance of the petitioners in the present Writ Petition stands redressed. However, if the petitioners are aggrieved by the said action taken by the respondents-authorities, it is open for them to avail further remedies under Cr.P.C./BNSS.

- 5. Granting liberty as noted hereinabove, the present Writ Petition is disposed of. No order as to costs.
- 6. Consequently, miscellaneous petitions, if any, pending shall stand closed.
