pleased to issue any writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondents more particularly Respondent No.5 interfering into the peaceful possession and enjoyment of the Petitioners over their developed Plots of Joint Venture Agreement dated 18/07/2006 under the name and style as Rosevilla Sree Priyanka Homes, in Sy.No.2, admeasuring Ac.2-01gts, situated at Dubbacherla Village and Grampanchayat, Maheshwaram Mandal, Ranga Reddy District, as illegal, arbitrary and violation of principles of natural justice and in violation of Articles 14 and 21 of the Constitution of India, besides violation of this Honble Court directions and consequently direct the Respondents more particularly Respondent No.5 not to interfere into the peaceful possession and enjoyment of the Petitioners over their developed Plots of Joint Venture Agreement dated 18/07/2006 under the name and style as Rosevilla Sree Priyanka Homes, in Sy.No.2, admeasuring Ac.2-01gts, situated at. Dubbacherla Village and Grampanchayat, Maheshwaram Mandal, Ranga Reddy District.

The Court made the following ORDER

THE HON'BLE SRI JUSTICE K. LAKSHMAN WRIT PETITION No.22527 of 2025

ORAL ORDER:

Heard learned counsel for the petitioners and Mr.B.Sridhar, learned Assistant Government Pleader for Home.

- This Writ Petition is filed to declare the action of 2. respondents, more particularly, respondent No.5 – Assistant Commissioner of Police, Maheshwaram Division, Rachakonda with the possession of Commissionerate, in interfering petitioners over the Developed Plots of Joint Venture Agreement, dated 18.07.2006 under the name and style of 'Rosevilla Sree Priyanka Homes', in Sy.No.2, admeasuring situated Dubbacherla Village, Acs.2.01 guntas, at Maheshwaram Mandal, Rangareddy District, as illegal.
- 3. Mr.B.Sridhar, learned Assistant Government Pleader for Home, on instructions, would submit that respondent Nos.2 to 6, more particularly, respondent No.5 never interfered with the possession of petitioners as alleged in the writ petition.

Petitioners have filed writ petition *vide* W.P.No.22330 of 2025 seeking police protection and the same was dismissed by this Court *vide* order dated 30.07.2025. Petitioners filed the present writ petition alleging interference of Police into the aforesaid plots pursuant to Joint Venture Agreement.

- 3. Perusal of the said Joint Venture Agreement would reveal that the signatures of respondent No.7 are there and there is no signature of petitioners. In W.P.No.22330 of 2025, respondent No.7 entered appearance through her counsel and disputed her signatures on the said Joint Venture Agreement, dated 18.07.2006. Therefore, without establishing their right, petitioners can't allege that police are interfering into the said Joint Venture. In the entire writ affidavit, there are no specific allegations against the Police and the allegations are only against respondent No.7, who is a private person. Therefore, the petitioners are not entitled for any relief much less the relief sought in the present writ petition.
- 4. Accordingly, this Writ Petition is liable to be dismissed and accordingly, dismissed.

Miscellaneous applications, if any pending, shall stand closed. There shall be no order as to costs.
