ORDER:

With the consent of the parties, this Writ Petition is being taken up for disposal at the admission stage itself.

- 2. Heard Sri P.Ugender Reddy, learned counsel for the petitioner; learned Government Pleader for Services-III for respondent Nos.1 to 4; and learned Government Pleader for Services-I for respondent No.5.
- 3. Learned counsel for the petitioner submits that though the petitioner was retired on 30.04.2025, till now, his retirement benefits were not released by the respondents.
- 4. Learned Government Pleader submits that the bills pertaining to the retirement benefits of the petitioner have already been processed, however, due to dearth of funds, the amounts could not be released to the petitioner, on time. Learned Government Pleader further submits that as per the seriatim of the token numbers, amounts will be released to the beneficiaries.
- 5. Having regard to the above made submissions, this Writ Petition is disposed of directing the respondents to release Gratuity (TS) amount of Rs.13,22,957/- with token No.2522440076 dated

14.08.2024, Gratuity (CS) amount of Rs.2,77,043/- with token No.2522440086 dated 14.08.2024, Commutation (TS) amount of Rs.18,98,778/- with token No.2522439975 dated 14.08.2024, Rs.3,97,627/with Commutation (CS) amount of No.2522440016 dated 14.08.2024, Final EL and HPL amount of Rs.12,50,457/- with token No.2522589706 dated 31.03.2025, GPF Final Payment of Rs.7,77,426/- with token No.2522594057, dated 31.03.2025, and GIS Final Payment of Rs.1,29,894/- with token No.2522589685 dated 31.03.2025, pertaining to the petitioner, as expeditiously as possible, preferably within a period of twelve (12) weeks from the date of receipt of a copy of this order.

Miscellaneous petitions pending, if any, shall stand closed.

There shall be no order as to costs.


