Petition under Section 528 of BNSS praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to call for the records in order dated 14/08/2025 in Crl.M.P.No.443 of 2025 in Crime No.460 of 2025, on the file of the court of the Special Judge at Hyderabad for Speedy Trial and Disposal of Cases of Fraudulent Drawls and Mis-Appropriation of Scholarship Amounts- Cum- II Additional Special Judge for Trial of SPE & ACB Cases -Cum- Special Judge for Trial of Cases under PDPP Act 1984, Hyderabad, and modify the conditions, more particularly, the condition of executing a personal bond of Rs.10,00,000/- with one surety.

Petition under Section 528 of BNSS praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to grant stay of the condition of executing a personal bond of Rs.10,00,000/- with one surety, stipulated in order, dated 14/08/2025 in Crl.M.P.No.443 of 2025 in F.I.R No.460 of 2025, on the file of the court of the Special Judge at Hyderabad for Speedy Trial and Disposal of Cases of Fraudulent Drawls and Mis-Appropriation of Scholarship Amounts- Cum- II Additional Special Judge for Trial of SPE & ACE Cases -Cum- Special Judge for Trial of Cases under PDPP Act 1984, Hyderabad, while releasing/returning of the vehicle, in the interest of justice and fair play pending the disposal of the above Criminal Petition.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri. ATLA ABHINANDHAN REDDY, Advocate for the Petitioner and the Sri. Jithender Rao Veeramalla, Additional Public Prosecutor on behalf of the Respondents.

**The Court made the following ORDER:**

CRIMINAL PETITION No.11066 of 2025

ORDER:

This criminal petition is filed seeking to modify the conditions imposed in the order dated 14.08.2025 in Crl.M.P. No.443 of 2025 in Crime No.460 of 2025 on the file of the Special Judge at Hyderabad for Speedy Trial and Disposal of Cases of Fraudulent Drawls and Mis-appropriation of Scholarship Amounts-cum II Additional Special Judge for trial of SPE & ACB Cases cum Special Judge for trial of cases under PDPP Act, 1984, Hyderabad.

2. Heard Mr. Atla Abhinandhan Reddy, learned counsel for the petitioner and Mr. Jithender Rao Veeramalla, learned Additional Public Prosecutor for the respondents.

3. Learned counsel for the petitioner submitted that the petitioner is the owner of the vehicle Innova Hycross bearing No.TG 08 H 1134 and the same was seized in Crime No.460 of 2025 of Jubilee Hills Police Station, Hyderabad, registered for the offences under Sections 125, 110, 281 and 54 of Bharatiya Nyaya Sanhita, 2023 (for short 'BNS'), 184 and 185 (a) of Motor Vehicles

Act and 3 of Prevention of Damage to Public Property Act (for short 'PDPPA'). The Vehicle belongs to the father of the accused No.1 and that the petitioner has filed petition under Section 451 Cr.P.C. before the trial court for release of the vehicle. The said petition was allowed and interim custody of the vehicle was ordered subject to executing a personal bond of Rs.10,00,000/- with one surety for the likesum and with other conditions. Learned counsel for the petitioner further submitted that the amount for executing the personal bond and the surety is too huge, and hence, prayed to reduce the same.

4. Learned Additional Public Prosecutor submitted that the vehicle is Innova Hycross, a brand new vehicle of recent registration, which is worth Rs.40,00,000/- and hence, prayed to dismiss the petition.

5. Perused the record.

6. The petitioner is the father of accused No.1, who is alleged to have driven the vehicle in a rash and negligent manner causing damage to a Metro Pillar on the road. The Registration Certificate of the vehicle is filed before the trial court and the said

observation is made by the concerned Officer and thus, the ownership is not in dispute.

7. Considering the submissions of the learned counsel for the petitioner and the fact that the vehicle i.e. Innova Hycross bearing No.TG 08 H 1134 is a newly purchased vehicle, this Court deems it appropriate to modify the order of the trial court dated 14.08.2025 passed in Crl.M.P. No.443 of 2025 in Crime No.460 of 2025 by reducing the amount of personal bond from Rs.10,00,000/- to Rs.5,00,000/- with one surety for the likesum. However, the other conditions in the impugned order shall remain unaltered.

8. The Criminal Petition is disposed of with the above modification. Miscellaneous Petitions pending, if any, shall stand closed.
