Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction especially one in the nature of Writ of Mandamus declaring that, a) the action of the Respondents in not making payment of terminal benefits to the Petitioner viz., Gratuity amount Rs.10,85,247/-vide Token No.2523956739 on 13.02.2025 and Rs.4,20,542/-vide Token No.2523956742 dated 13.02.2025. Commutation was also sanctioned by the Audit Officer, Directorate of State Audit, Telangana, Hyderabad vide Lr.No. PH/HO/2471/2024 dated 02.12.2024 an amount of Rs.10,47,658/- vide Token Nos.2523956744 dated 13.02.2025 and Rs.4,05,975/- vide Token No.2523956747 dated 13.02.2024. The final Encashment of Leave amount of Rs.11,38,020/- was sanctioned on 05.05.2025 vide Token No.2600117502. General Provident Fund amount of Rs.8,98,138/- was sanctioned on 29.03.2025 vide Token No.2524104414. D.A. Arrears amount of Rs.74,455/- was sanctioned on 18.02.2025 vide Token No.2523909012. b) the Respondents have no

right or power to withhold the terminal benefits payable to the Petitioner after his retirement

General Provident Fund amount of Rs.8,98,138/- was sanctioned on 29.03.2025 vide Token No.2524104414. D.A. Arrears amount of Rs.74,455/- was sanctioned on 18.02.2025 vide Token No.2523909012, pending disposal of the Writ Petition

ORDER:

With the consent of the parties, this Writ Petition is being taken up for disposal at the admission stage itself.

2. Heard Sri G.Jalpath Reddy SVR, learned counsel for the petitioner; learned Government Pleader for Services-III for respondent Nos.1, 3 to 5; and learned Government Pleader for Services-I for respondent No.2.

3. Learned counsel for the petitioner submits that though the petitioner was retired on 31.12.2024, till now, his retirement benefits were not released by the respondents.

4. Learned Government Pleader submits that the bills pertaining to the retirement benefits of the petitioner have already been processed, however, due to dearth of funds, the amounts could not be released to the petitioner, on time. Learned Government Pleader further submits that as per the seriatim of the token numbers, amounts will be released to the beneficiaries.

5. Having regard to the above made submissions, this Writ Petition is disposed of directing the respondents to release Gratuity amount of Rs.10,85,247/- vide Token No.2523956739 dated

13.02.2025 and Rs.4,20,542/- vide Token No.2523956742 dated 13.02.2025, Commutation amount of Rs.10,47,658/- vide Token Nos.2523956744 dated 13.02.2025 and Rs.4,05,975/- vide Token No.2523956747 dated 13.02.2024, final encashment of leave amount of Rs.11,38,020/- vide Token No.2600117502 dated 05.05.2025, General Provident Fund amount of Rs.8,98,138/- vide Token No.2524104414 dated 29.03.2025, D.A. arrears amount of Rs.74,455/- vide Token No.2523909012 dated 18.02.2025, pertaining to the petitioner, as expeditiously as possible, preferably within a period of twelve (12) weeks from the date of receipt of a copy of this order.

Miscellaneous petitions pending, if any, shall stand closed.

There shall be no order as to costs.

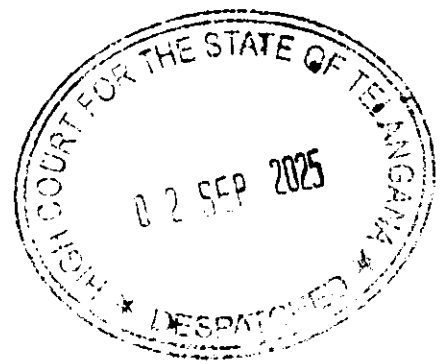
