extent of Ac.4.36 Guntas situated at Tirumalapur Village, Kulkacherla Mandal, Vikarabad District, Telangana State by the respondents No.3 and 4 as illegal, arbitrary and in violation of Principles of Natural Justice and in violation of Articles 14, 16, 19, 21 and 300-A of Constitution of India, Consequently direct the respondents No.2 and 3 to consider the Representations dated 30-06-2020, 27-06-2020, 15-07-2021 and 10-12-2024 filed by the petitioners by not allowing the respondent No. 4 in civil matters in respect of the petitioners land in Sy.No.67/A and 68/E total to an extent of Ac.4.36 Guntas situated at Tirumalapur Village, Kulkacherla Mandal, Vikarabad District, Telangana State

The Court made the following: ORDER

THE HONOURABLE SRI JUSTICE B. VIJAYSEN REDDY WRIT PETITION No.25595 OF 2025

ORDER: (ORAL)

Heard Mr. V.R. Mannepalli, learned counsel for the petitioners, learned Assistant Government Pleader for Revenue, appearing for respondent Nos.1 to 3, and learned Assistant Government Pleader for Home, appearing for respondent No.4.

- 2. Learned Assistant Government Pleader for Home placed on record written instructions dated 28.08.2025 and submitted that on the complaint of one Mr. Subash Karankot, a case in Crime No.139 of 2025 was registered with Kulkacherla Police Station for the offences punishable under Sections 329(3), 115(2), 351(2) and 352 read with Section 3(5) of the Bharatiya Nyaya Sanhita 2023 (BNS), wherein the petitioners are accused and respondent No.4 is conducting investigation.
- 3. Learned counsel for the petitioners submitted that there is interference by respondent No.4 with the land of the petitioners admeasuring Acs.4-36 guntas in Survey Nos.67/A and 68/E

situated at Tirumalapur Village, Kulkacherla Mandal, Vikarabad District, without following due process of law.

- 4. A copy of written instructions along the copy of FIR is served on learned counsel for the petitioners.
- 5. In view of the above, the writ petition is disposed of, directing respondent No.4 the Station House Officer, Kulkacherula Police Station, not to interfere in the civil disputes between the petitioners and Mr. Subhash Karankot *de facto* complainant in Crime No.139 of 2025, in respect of the land admeasuring Acs.4-36 guntas in Survey Nos.67/A and 68/E situated at Tirumalapur Village, Kulkacherla Mandal, Vikarabad District, without following due process of law. However, this order shall not come in the way of respondent No.4 in conducting investigation in Crime No.139 of 2025 of Kulkacherula Police Station, by following due process of law. Further, this order shall not have any bearing on the *inter se* disputes with regard to the title and possession over the subject land between the petitioners and

the *de facto* complainant in Crime No.139 of 2025 of Kulkacherla Police Station. There shall be no order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in the writ petition stand closed.
