ORDER:

Heard learned counsel for the petitioner, Sri N.Sridhar Reddy, learned Standing Counsel appearing for respondent No.2, and learned Government Pleader for Energy appearing for respondent Nos.3.

- 2. The main grievance of the petitioner in the present Writ Petition is to the action of the respondents, more particularly respondent No.2 in cutting and removing the petitioner's cables without any notice and consequently sought for a direction to the 2nd respondent to stop cutting or removing the fiber optic cables of the petitioner-Company laid on the poles of the 2nd respondent.
- 3. Evidently, the petitioner had approached the 2nd respondent by submitting a representation, dt.25.08.2025 (received on 26.08.2025), seeking permission for utilization of electric poles for Internet Services.
- 4. Learned Standing Counsel appearing for the 2nd respondent submits that the petitioner having approached the 2nd respondent by submitting a representation, dt.25.08.2025, received on 26.08.2025, without even waiting or giving the authorities breathing time to consider and pass orders on the said

representation, has approached this Court by filing the present Writ Petition on 26.08.2025.

- In view of the above, this Court is of the view that the 5. present Writ Petition as filed is premature.
- Accordingly, the Writ Petition is dismissed. No order as to 6. costs.

Consequently, miscellaneous applications, pending if any, shall stand closed.
