CIVIL REVISION PETITION No.3977 OF 2024 AND CONTEMPT CASE No.2697 OF 2024

COMMON ORDER:

C.R.P.No.3977 OF 2024:

This Civil Revision Petition is filed aggrieved by the docket orders, dated 06.12.2024 and 10.12.2024, passed in SR.Nos.3364 of 2024 and 3389 of 2024, respectively, by the learned Principal Junior Civil Judge, Medchal-Malkajgiri District at Medchal, whereby, the R.C. filed by the petitioners, under Section 14 of the Telangana Buildings (Lease, Rent and Eviction) Control Act, 1960, was not being entertained.

- 2. Heard Sri M. Phanindra Pavan Kashyap, learned counsel for the petitioners and Sri B. Balaiah, learned counsel for the respondents.
- 3. Learned counsel for the petitioners had contended that the petitioners are tenants of the respondents. At the instance of the respondents, electricity connection and water supply were disconnected to the subject premises. Therefore, the petitioners

approached the trial Court by filing the subject R.C., but the trial Court refused to entertain the same. In those set of circumstances, the present Civil Revision Petition is filed seeking a direction to provide electricity connection and water supply to the subject premises and this Court, vide docket order, dated 13.12.2024, was pleased to direct the respondents to provide water supply and electricity connection to the subject premises. Pursuant to the same, the petitioners as well as the respondents submitted a representation to the authorities concerned for providing electricity connection and water supply. As the authorities concerned were not acting on the same, the petitioners filed W.P.No.2542 of 2025 before this Court and the said Writ Petition was disposed of on 30.01.2025, directing the Assistant Engineer, Operations, Telangana State Power Distribution Company Limited, to consider the representation submitted by the petitioners. But the authorities concerned are not still considering the same. Therefore, appropriate orders be passed in the Civil Revision Petition by directing the authorities concerned to provide electricity connection and water supply to the residence of the petitioners.

- 4. On the other hand, learned counsel for the respondents had contended that the petitioners are not the tenants of the respondents and that the respondents are taking steps to file an ejection petition against the petitioners. Therefore, appropriate orders be passed in the Civil Revision Petition.
- 5. This Court, having considered the rival submissions made by the learned counsel for the parties, is of the considered view that Hyderabad Metropolitan Water Supply and Sewerage Board (for 'HMWSSB') and Telangana State Power Distribution Company Limited (for short, 'TGSPDCL') are the authorities concerned, which provide electricity connection and water supply to the subject premises. As HMWSSB and TGSPDCL are not parties to the present Civil Revision Petition, this Court is of the considered view that the present Civil Revision Petition can be disposed of by directing the petitioners to file a Writ Petition impleading TGSPDCL as well as HMWSSB as parties, so as to enable them to comply with the docket order, dated 13.12.2024, passed by this Court in C.R.P.No.3977 of 2024. Further, the trial Court is directed to number the subject R.C. preferred by the

petitioners, in accordance with law and pass appropriate orders on merits, after giving opportunity to everyone concerned.

6. With the above observations/directions, the Civil Revision Petition is disposed of.

C.C.No.2697 of 2024:

- 7. This Contempt Case is filed seeking to punish the respondents for willful and deliberate violation of the docket order, dated 13.12.2024, passed by this Court in C.R.P.No.3977 of 2024.
- **8.** In view of the order passed in the Civil Revision Petition, no further orders are required to be passed in this Contempt Case.
- **9.** Accordingly, the Contempt Case is closed.

Miscellaneous Applications, if any, pending, shall stand closed. There shall be no order as to costs.
