**Order**

1. The petitioners have preferred these bail applications under Section 483 of B NSS in FIR No.0002/2025 registered at Police Station-Khairthal, District-Khairthal-Tijara for offences under Sections 309(4), 311 and 3(5) of the BNS.
2. Since both the bail applications arise out of common FIR, therefore these cases are being decided by a single order.
3. Heard learned counsel for the petitioners as well as learned Public Prosecutor and perused the material available on record.
4. Learned counsel for the petitioners submits that the

petitioners have falsely been implicated in these cases. He submits that other co-accused-Dharmendra @ Dhara Singh and Ajay have already been enlarged on bail by this Court on 13.05.2025. He again submits that petitioner-Anil Kumar is behind the Bar since 09.01.2025 and Baljeet Singh @ Balli is behind the Bar since 10.01.2025. Charge-sheet has been filed. The trial of the case may take considerable time. Hence, on the ground of parity, the bail applications of the petitioners may be allowed.

5. Learned Public Prosecutor has vehemently opposed the bail applications.

6. On consideration of the rival submission and material available on record and deliberating all the facts and circumstances of the case, on the ground of parity but without expressing any opinion on the merits/demerits of the case, I am inclined to grant benefit of bail to the petitioners.

7. Accordingly, the bail applications under Section 483 B.N.S.S. is allowed and it is ordered that the petitioners- **(1) Anil Kumar S/o Shri Harinarayan (2) Baljeet Singh @ Balli S/o Vedprakash** shall be released on bail on their furnishing a personal bond in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to the satisfaction of the learned trial court for their appearance before that Court on all the dates till conclusion of the trial.
